

Eligible persons and applicants

Persons eligible for support Children who satisfy both conditions on the right are eligible. There is no income limit.

- 1 Persons aged from 0 to 18 years before the first March 31 after reaching those ages
- 2 Persons who have or had an address in Tokyo in AY 2026 (in principle)

Applicant

If the child is younger than 18 years of age, the application must be submitted by a parent or guardian. For children aged 18 years, an application may be filed by their parents and guardians or by the children. *Children who turn 18 years old during AY 2026 can file an application in person after their birthday.

Support period and amount of payments

Verification of address The verification of address is based on the status on the first day of each month.

Payment start time

- A** Persons moving to or who were born in Tokyo on the first day of a month become eligible for support in **that month**.
B Persons moving to or who were born in Tokyo on the second or later days of a month become eligible for support in the **following month**.

Living in Tokyo since before April 2026

Support period: 12 months

2026 2027
Apr. 12 months Mar.

Amount paid 5,000 yen monthly x 12 months = **60,000 yen**

Moving to or born in Tokyo on June 1, 2026

Payable period: 10 months

2026 2026 2027
Moving to Tokyo on June 1 June 10 months Mar.

Amount paid 5,000 yen monthly x 10 months = **50,000 yen**

Moving from Tokyo on Dec. 1, 2026

Payable period: 9 months

Amount paid 5,000 yen monthly x 9 months = **45,000 yen**

Frequently asked questions

Q1

What is the purpose of this support program?

This program provides each child aged 18 years or younger living in Tokyo with 5,000 yen monthly (up to 60,000 yen per year) and aims to seamlessly support the learning and development of children to realize a child raising-friendly environment in Tokyo.

Q2

For a child aged younger than 1 year, does the amount paid vary depending on the date of birth?

Yes, the amount paid varies depending on the date of birth. (To be eligible, a child needs to be living in Tokyo on the first day of each month.) For example, a person born on May 1, 2026, receives the payment starting in May 2026. A person born on May 2, 2026 receives the payment starting in June 2026.

Q3

Is a child living abroad or in a school dormitory outside Tokyo eligible for the payment?

Children who are temporarily living abroad or in a school dormitory outside Tokyo for study are eligible for the payment. For instructions on how to apply and the required documents, please contact us or check the website.

About Childcare Support Plus

To help childrearing households, 11,000 yen is provided once to each child aged 0 to 14 years without the need for an application. For more details, please see the website.

Persons eligible for support

- Residents of Tokyo aged 0 to 14 years in the period from February 2, 2026, to April 1, 2027 (residents with the date of birth from April 2, 2012, to April 1, 2027)

About the Tokyo Metropolitan Government Childbirth and Childcare Support Project

You can apply for the 018 Support and the Tokyo Metropolitan Government Childbirth and Childcare Support Project (Baby First gift and Baby First+ [Plus]) at the same time.

Persons eligible for support

A caregiver who

- 1 has a child born on or after April 1, 2025, and
- 2 has an address in Tokyo on the date of birth of the child

Application deadline has been extended

The application deadline and the card registration deadline have been extended.

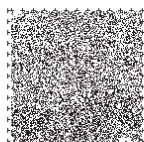
Taxation

When the only annual income of the child is the 018 Support payments and the Childcare Support+ (plus), then the support payments are not taxed.

*If an eligible child has income other than the 018 Support payments and the Childcare Support + (Plus), or is living outside Japan, the payments may be taxed.

Exclusion of income from public income support

The 018 Support payments and the Childcare Support+ (plus) will not be recognized as income.

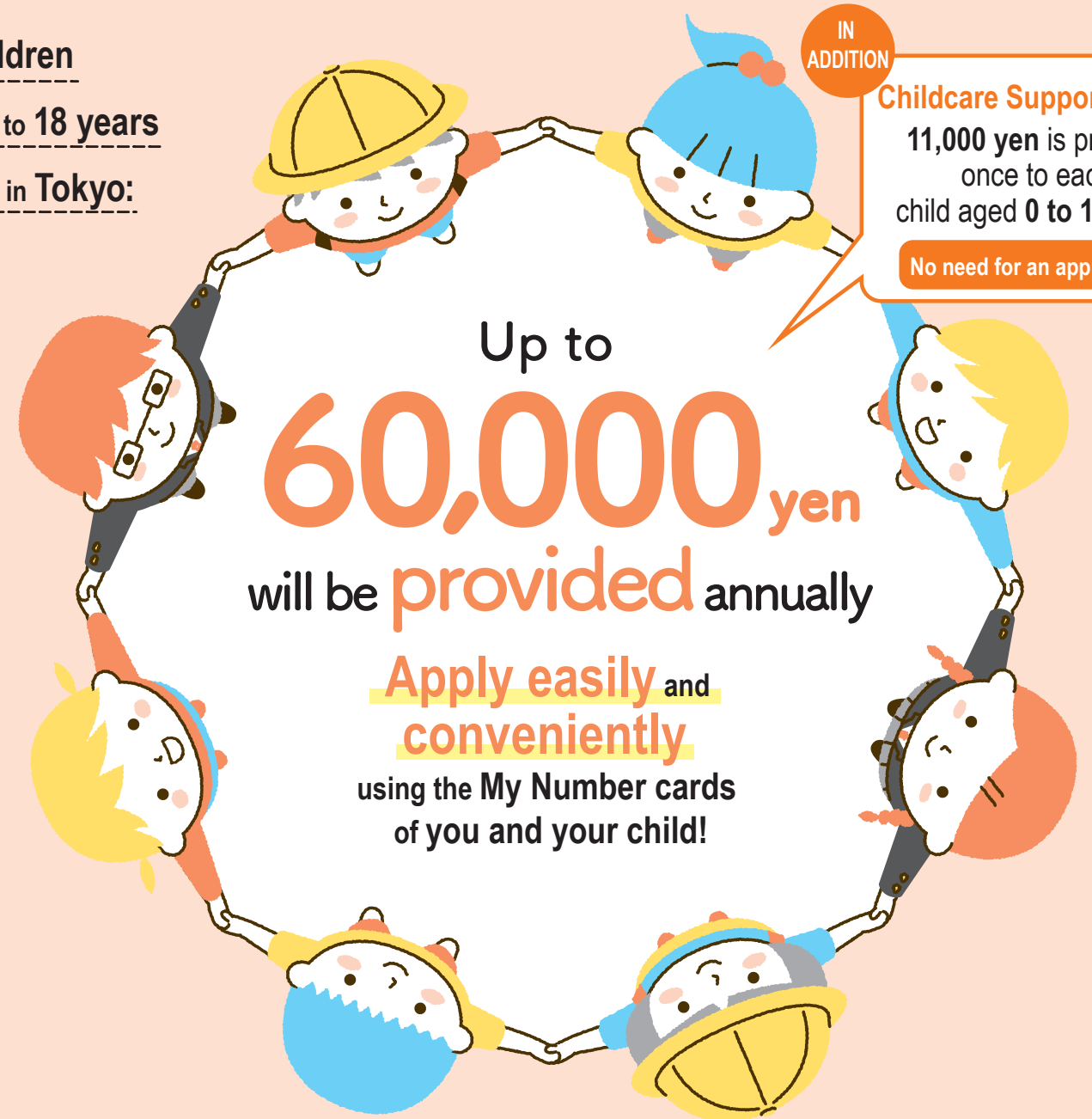

Payments start in August

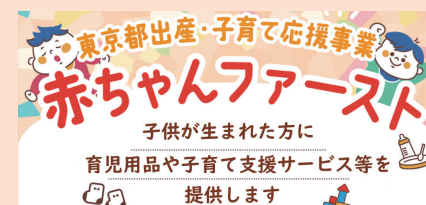
Application filed by Sunday, Nov. 1, 2026:

Payments start in December

Application filed by Monday, Mar. 1, 2027:

Payments start in April

Children aged 0 to 18 years living in Tokyo will be provided with 5,000 yen monthly. In AY 2026, support payments will be made three times in August, December, and April.



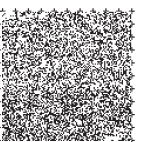

If you and your child have My Number cards and if either of you have an account registered to receive public money, you can apply easily and conveniently by holding the My Number cards of you and your child over a smartphone.

*Access the 018 Support website via the 2D code on the left and file an application using either method shown below.

Recommended: easy and convenient!

How to apply by holding the My Number cards of you and your child over a smartphone

You can apply by entering the four-digit PINs of the My Number cards of you and your child and holding the cards over a smartphone.



[Conditions for applying]

You can apply by this method if the following applies:



Both you (applicant) and your child (eligible person) have My Number cards.



Either of you have an account registered to receive public money.



Both of you have a registered address on the resident register in Tokyo and live in the same household.

*Applicants aged 18 can apply only with their My Number card (with a registered public money deposit account).

What to prepare

My Number card of your child

Persons eligible for support

*The four-digit PIN must be input.



For children aged younger than 18 years

My Number card of a parent

Applicant

*The four-digit PIN must be input.



Registered public money receiving account

Must be pre-registered on Mynportal

*Either the applicant or the eligible person must have an account registered to receive public money.



MynaApp

*You may download the app during the application process.



If you have no registered account

For the application, either the eligible child or the applicant must have an account registered to receive public money. Please log in to the Mynportal and register an account.

*You can file an application from the day after account registration.

Application flow

- 1 Read the child's My Number card twice
- 2 Read the My Number card of the applicant father or mother twice
- 3 Select a deposit account
- 4 Input your contact information (phone number and email address)
- 5 Confirmation of pledges and agreements

How to apply if the method on the left is not available

What to prepare

Information of the applicant

Either (A) or (B)

(A) My Number card



(B) •Driver's license
•Passport
•Certificate of health insurance status

Two of IDs listed above

A document that verifies the applicant and the child as family members

(A), (B), or (C)

*This is not required if a child aged 18 years files an application.



(A) Medical certificate for the child

*Indicating the address and date of birth of the child



(B) Certified copy of the resident register

*Indicating the information and relationship of the applicant and the child



(C) Certificate of health insurance status

*Verifying the child as a dependent of the applicant

Document verifying a bank account



A part of a bank book or cash card that indicates the bank name, branch name, account number, and account holder is required.

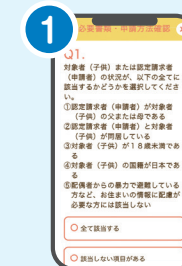
*A capture of an online banking page indicating the necessary information is also acceptable.
*You can select either the applicant's account or the child's account.

*Additional documents may become necessary depending on the status of the child. Please check the website for more details.

*If the child is aged 18 years but if a parent and guardian files an application, a power of attorney from the child is required.

Account registration

Register your email address and password.



Register the applicant's information

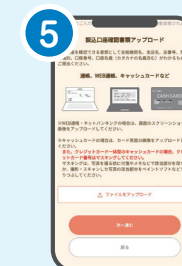
Register the applicant's ID documents and input the applicant's information.

*To request payment to the applicant's account, input the account information.



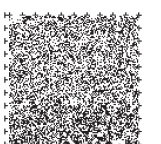
Register the eligible child's information

Input the eligible child's information. Upload a document that verifies the family relationship.



Select the account to receive payment

You may select either the applicant's account or the child's account to receive payment.
